 - **Applications** : in human food (Africa, Asia) but mainly intended for animal feed (Europe)


Introduction

Aims D Manufacturing sorghum flour-based salted biscuits.

- **One health approach** (whole grain flour, low fat and salt contents). **Naturality** (using a simple recipe with no additives).
- □ Using RSM to study the effect of dough hydration and its oil content on multiple dough characteristics as well as those of corresponding biscuits.
- □ Designing a recipe compatible with the industrial rotary molding technology used in the biscuit industry.

□ Developing a new sustainable sorghum sector for human consumption.



Materials and Methods

> Experimental design


- > Manual manufacturing biscuits and analyses [2]
- **300 g of dough** containing:
 - + a mix of whole grain flours (S/CP) as follow: 75% white Sorghum flour (cultivar Arabesk) 25% Chickpea flour
 - or whole Wheat flour as control
 - + Water
 - + Salt (1.2 % of the dough)
 - + Oleic sunflower oil



Analyses of the dough :

viscoelastic and rheological properties of the doughs through the determination of elastic (G') and viscous (G'') modulus in the linear deformation domain, maximum force reached during a 20% dough compression (Fmax comp) and relaxation index (RI) were measured using a rotational rheometer (Kinexus Lab+, Netzsch).

Analyses of the biscuits :



Aw, water content, density, dimensions, volume, spreading ratio and hardness.

A two-factors centered composite design (dough hydration and oil content) with five replicates of the center point for uniform accuracy was realized [3] (Table 1). Three checkpoints were also carried out.

The effects of the experimental centered composite design were described by the following second order polynomial model:

$Y = b_0 + b_1 x_1 + b_2 x_2 + b_{12} x_1 x_2 + b_{11} x_1^2 + b_{22} x_2^2$

where Y was the predicted response, x₁ and x₂ the centered coordinates related to respectively dough hydration and oil content, b_i the coefficients of the effects of the factors (b_0 the mean of the responses; b_1 the linear effect of dough hydration; b₂ the linear influence of dough oil content; b₁₂ the influence of interaction between dough hydration and oil content; b_{11} the quadratic influence of dough hydration and b_{22} the quadratic influence of oil content).

□ The results-were analyzed using the Statgraphic Centurion V19.1.3 software developed by Statpoint Technology, Inc. The repeatability was estimated thanks to the replicates performed at the central point of the experimental domain. This estimate was used to evaluate, using a Student test, the significance of the coefficients calculated for the models. The acceptance threshold chosen was 5%.

Results

> Viscoelastic, rheological properties and aspect of the dough

- The hydration of the dough and its oil content both had a negative linear effect on G' and on the Fmax-comp (table 2).
- The dough had a more elastic than viscous structure (G'>G") (not shown).
- S/CP doughs exhibited G' values between 5.33.10⁴ Pa and 1.62.10⁵ Pa, with a mean of 4.19.10⁵ Pa for the central points of the domain. This average was four times higher than the values recorded for a control dough made from wheat (G' = $1,31.10^5$ Pa).
- The elastic structure of the S/CP dough was therefore weakened with the increase in the percentage of hydration and oil added to the dough, the effect of hydration being greater than that of the oil content.
- Fmax-comp determined the maximum force to compress the




Fig. 1 – Surface response of Fmax compression (a) and relaxation index (b) of the dough as a function of dough hydration and oil content.

- The high values of Fmax-comp were recorded for low hydration doughs that were drier, grainy and lacked cohesion (Fig 1(a)). Doughs with a high hydration percentage were more cohesive.
- The hydration of the dough had a positive linear effect and a negative quadratic effect on the RI. A significant negative interaction between the hydration and the oil content on this rheological characteristic was also observed (table 2).
- RI reflected the behaviour and time taken by the dough to relax following the compression stress. It may be related to the elasticity of the dough. The higher it was, the more the dough relaxed and the more elastic it was.
- RI values ranged from 76.72% to 88.45%, with an average of 87.26% for the points at the center of the domain. An optimum was achieved for formulations close to the center of the experimental (27.5% hydration of dough) (Fig 1(b)). The doughs with the highest RI (between 86% and 87%) corresponded to the points of the experimental domain with a percentage of hydration of the dough close to that of the center of the experimental domain.

• The dough containing 27.50% (wb) water and 13.25% oil (center point) successfully lead to rotary molded biscuits (table 3). The dough with 25.73% (wb) water content and 12.01% oil was difficult to process by rotary molding. Finally, the dough with 29.27 % (wb) water content and 14.49 % oil was impossible to process with this technology

dough by 20% and characterized its consistency. The Fmaxcomp measured at the center of the experimental domain were 26.7 N. The lower the percentage of hydration and oil in doughs, the more difficult it will be to compress them because the more consistent they will be.

 - The most critical parameter to control is then the water content of the dough, with a very narrow optimal window (*i.e.* low water content) for rotarymolding ability that was correlated to the maximum of the dough RI measured on the whole experimental domain.
